Amendment in Parental Authority System

The bill for partial revision of the civil and other related law was passed on May 27th, and was promulgated on June 3rd. The revision in parental authority is a drastic change in child abuse and neglect prevention. I will briefly follow the changes made by the revision.

First, it was made clear that the child must be guarded and educated "for the child's benefit". It is definitely on the law, now that a child may not be secondary to any adult's personal reasons but fundamentally to be thought from their benefit.

The only option we had was the "forfeiter of parental authority". Since this was rarely filed, the revised bill included "suspension of parental authority up to two years". Also, the child him/herself is now able to file a petition for forfeiter and/or suspension of parental authority.

Another clarification was made on this revision. The Child Welfare Act originally says that a director of a residential institute may take action when the child is in need. However, most claim by the person exercising parental authority or the guardian of a minor was given priority. This time, it made it clear that "a person exercising parental authority or guardian of a minor may not unjustly disturb the director taking action".

Other changes by this revision included: "the guardian of a minor could be multiple person or a corporate as well as an individual", "review of the discipline system (when a child makes a wrongful action, residential institute may give a decent punishment)", "visits are also to be set on divorce trial", "review of law taking temporal custody" and "maintenance of the related other law".
